CHAPTER 7 THINGS TO DO LIST:

1. LIST ALL CREDITORS ON PAGES PROVIDED AT THE END OF THE FORM, **INCLUDING ALL MORTGAGE COMPANIES, AUTO LOANS, MEDICAL BILLS, CREDIT CARDS, PAYDAY LOANS, FINANCE COS., STUDENT LOANS, ETC!!**
2. BRING CURRENT **PROPERTY TAX BILL** (must include "APPRAISED" value) FOR ALL LAND, HOMES OR OTHER BUILDINGS EITHER IN YOUR NAME **AND/OR** FOR THOSE THAT HAVE BEEN TRANSFERRED OUT OF YOUR NAME IN THE LAST 2 YEARS.
3. BRING TAX RETURNS FROM THE PAST THREE (3) **YEARS**. THIS MUST INCLUDE **FEDERAL AND STATE RETURNS. IRS 1-800-829-1040 (For federal tax forms).**
PLEASE PROVIDE **W-2S AND 1099S** WITH YOUR RETURNS.
4. BRING IN THE **LAST TWO MONTH'S** OF PAY STUBS OR PRINTOUT FROM EMPLOYER, OR PROOF OF OTHER INCOME. Stubs must be consecutive and up to the date of filing.
This Includes Social Security, Retirement, Benefits, Pension, All Full and Part Time Jobs.
5. BRING PICTURE I.D. AND SOCIAL SECURITY CARD.
6. BRING IN THE LAST 3 MONTHS OF STATEMENTS FOR **ALL** BANKING OR INVESTMENT ACCOUNTS. MUST HAVE A STATEMENT FOR **EACH ACCOUNT #**. (I.E. - checking, savings, money market, investment account, etc.). We need these statements even if the account has been closed in the last 3 months or has no balance.
7. CREDIT COUNSELING (www.AcademyofFinancialLiteracy.com). If you would like a list of alternative counselors please ask an employee of the firm.
